#### **Executive Summary**

Spirit of America's mission is to help Americans serving abroad assist local people in need. We meet needs identified by American military and civilian personnel for items that will help local people.

In 2009 over \$2,000,000 was spent on program goods in Afghanistan, Iraq and Africa. Spirit of America provided the following:

Tons of medical equipment and supplies, first aid kits, midwife kits, crutches, wheelchairs and hygiene kits.

Security equipment, including: eyewear, boots, camelback hydration systems, tool kits, fleece pullovers and caps.

Solar-powered radios to open Afghan villages to ideas, information and music.

To support Afghan farmers and their families: solar lanterns, solar panel water pump systems and saffron bulbs for planting.

To support the local families in need: fleece blankets, traditional Afghan clothing, shoes, winter coats and boots, backpacks filled with school supplies, sports equipment (including soccer balls, volley balls and nets), playground equipment, toys and more.
